- M.Ed. Multi-Cat non-licensure track- Areej Ahmed
 - The M.Ed. in Multi-categorical Special Education with Autism includes two tracks: 1) a non-licensure track for candidates holding a valid Professional Teaching License but not seeking licensure and 2) a licensure track for non-licensed candidates seeking a Professional Teaching Licensure. The purpose of this proposal is to revise the current M.Ed. in Multi-categorical Special Education with Autism track for candidates holding a Professional Teaching License. The track for non-licensed candidates will remain the same.
- The State of WV recently passed a new option for alternative certification that may lead to fewer applicants seeking licensure and additional applicants holding a teaching license. The proposed program revisions will make the non-licensure track more competitive with other non-licensure education programs and will provide elective course options to help teachers support students who have experienced trauma. The proposed changes would remove 6 hours from the current track for licensed candidates, reducing it from 36 to 30 hours. SPED 6390 Special Education Practicum would be removed

State Requirements:

Cooperating teacher requirements for both student teaching and residency are the same :\\$126-114-5.12.a Effective July 1, 2018, cooperating teachers for clinical experience should, at a minimum:

- 1) hold a valid West Virginia five-year teaching credential in the content area of the candidate placed in their classrooms with a minimum of three years of teaching experience;
- 2) hold "Accomplished" or higher as a summative performance rating on the West Virginia Educator Evaluation during the last two years of employment; and
- 3) have successfully completed a WVBE-approved cooperating teacher course, at no cost to the teacher,
- <u>or</u> hold or be eligible for the Mentor or Master Mentor Advanced Credential <u>or</u> hold certification through the National Board for Professional Teaching Standards (NBPTS).

- Survey link- Assessments due April 20 Danielle will be sending those out to host teachers tomorrow. Please be sure to check with them and verify that it was received.
- State Partnership Updates- funding, direction The state is centering more on Placement sites (Hubs) than Professional Development Schools. They are focusing on the Year Long Residency. The grant information has not been distributed yet. I will receive that information in May.
- Non-degree summer courses. FSU will not be having these. We will be concentrating on rolling out Resident Program. The state indicated that they will recognize the Non-degree course that Keisha and Toni have conducted. We will probably be hosting that in the fall. Information will be forthcoming. Cost is minimal and it will be helpful to those hosting a Resident student (but not required)
- Ed. Leadership M.ED/Certificate update- All online and taught by practitioners. There are 4 different options available: M.Ed. (30 hours), principalship,(18 hours) Principal and Superintendent (24 hours) and Superintendent only (6 hours). Only institution in state offering all 4 options. will send new flyer to share
