I. **PROPOSAL**. Write a brief abstract, not exceeding 100 words, which describes the overall content of the proposal.

The Outdoor Recreation Leadership minor was developed 7 years ago. With changes in the Outdoor Recreation Field, the Outdoor Recreation Faculty believes the minor needs to be updated for better alignment with current trends.

It is proposed to reduce the credit hours required to graduate with a minor in Outdoor Recreation Leadership from 24 to 20 by changing the core that is required from 20 to 14 credit hours within the current curriculum and changing the elective requirement from 4 credit hours to 6.

The courses that are currently listed in Minor Electives Group I will be removed. Six credit hours of outdoor recreation activity courses that are currently offered within the curriculum will replace those listed under the Minor Electives Group 1.

All other current course offerings will be placed in Minor Electives Group II.

These changes will make the minor more functional and attractive while providing a stronger, more applicable base of course work to the students choosing a minor in Outdoor Recreation Leadership.

The following course descriptions will have the course prerequisites removed. RECR 1177 (Adventure Water Sports), RECR 2220 (Program Planning and Organization) and RECR 3330 (Group Leadership). Course prerequisites currently required are not necessary for course completion and success.

PHED 2240 Outdoor Leisure Activities...... 2 hrs.

Safety, knowledge and skills specific to incorporating outdoor recreation into the physical education classroom. Activities are applied and analyzed through the following: experiential education, rappelling, rock climbing, orienteering, geocaching, and others. (New course description for catalog) *Note for information only: This course is not a part of the Outdoor Recreation Leadership minor. It is a course offered to Physical Education and Exercise Science majors taught by the Outdoor Recreation Leadership faculty.*

RECR 1177 Introduction to Adventure Water Sports...... 2 hrs.

This course provides an introduction to various adventure water activities including one or all of the following: canoeing, kayaking and white water rafting. Students investigate trip planning, water safety, "Leave No Trace" ethics, and equipment use and care. Students will be introduced to these activities through experiential learning in the swimming pool and trips on regional rivers. All students must pass a basic swim test to show competency and ease in the water (Ability to swim 50 yards and tread water for 5 minutes required). (New course description for catalog)

RECR 1188 Introduction to Adventure Winter Sports...... 2 hrs.

This course provides an introduction to various adventure winter activities including one or all of the following: Cross country skiing, Snow Shoeing, Downhill Skiing, Snowboarding, Winter Camping and Mountaineering. Students will be introduced to these activities through experiential learning in and around campus and trips to regional ski and Nordic centers. (New course description for catalog)

RECR 2220 Program Planning and Organization...... 3 hrs.

A presentation of the underlying principles for effective recreation planning. Attention is given to the variety of programs associated with recreation and the interests of the participants. Students will also examine methods of planning, organization, leadership, facilities and equipment. Independent Study. *Instructor Approval.* (New course description for catalog)

RECR 3330 Group Leadership...... 3 hrs.

This course presents information on group dynamics, leadership styles, activity facilitation, risk management, liability issues, and planning. Students will obtain practical knowledge of group situations and principles necessary for effective leadership. Opportunities to develop their own leadership skills through peer teaching will be provided. (New course description for catalog)

The hours needed to attain a minor in Outdoor Recreation Leadership will be reduced by 4 credit hours. See Appendices A & B

III. RATIONALE FOR THE PROPOSAL.

The Outdoor Recreation Leadership Minor was established 7 years ago. As of the Fall Semester 2013 there were 4 students in the Outdoor Recreation Leadership Minor.

The number of hours required (24) is more than most minors at Fairmont State University. 24 credit hours are more than most other institutions (regionally & nationally) offering a similar minor. The proposed change in number of minor hours required will allow the Fairmont State Outdoor Recreation Leadership minor to be more competitive.

The current required minor courses and electives are not able to be taught on a regular basis due to the limited number of faculty in the Outdoor Recreation Leadership program. The lack of course availability limits the number of students that are able to complete the minor. Reducing the total number of required minor credit hours will enable courses to be offered on a regular basis (at least once each academic year), thereby enabling students to plan, schedule and obtain a minor in a more timely fashion.

The realignment of courses within the minor makes it more relevant to the Outdoor Recreation profession and to the standards set by the Association for Experiential Education and the Association for Outdoor Recreation and Education.

Course prerequisite removal: The following prerequisites are being removed from courses because they are not necessary for course completion or success.

- RECR 1177 (Adventure Water Sports) will no longer have a water-based prerequisite (PHED 2232, 2233 or 3381). Students taking this course must pass an in class swim test to ensure that they are capable of self-rescue.
- RECR 2220 (Program Planning and Organization) and RECR 3330 (Group Leadership) will no longer require RECR 1141 (Introduction to Recreation).
- Instructor approval has been added to RECR 2220 (Program Planning and Organization) due to the independent study set up of the course.

There is no increase in cost to this change. There will be no new faculty needed. We expect the numbers in the Outdoor Recreation Leadership minor to grow as a result of this change.
