PSYC 4490 (Directed Research) and PSYC 4480 (Directed Studies) will continue to focus on psychology-oriented projects and readings. Please see Appendix B for a new course description.

The course descriptions do not affect the content that is taught in PSYC 4490 and PSYC 4480 and the courses still satisfy the same course outcomes regarding assessment. Please see Appendix B for the course outcomes and a course outline.

PSYC 4470 (Intervention Techniques and Applications) will continue to focus on operant techniques and methodologies. Please see Appendix B for a new course description.

This course description also does not affect the content that is taught in PSYC 4470 and the course still satisfies the same course outcomes regarding assessment. Please see Appendix B for the course outcomes and a course outline.

Furthermore, these two courses, PSYC 3340 and PSYC 4470 are the same and should be considered the same for D/F repeat purposes.

We are proposing PSYC 3340, Intervention Techniques and Applications, be changed to PSYC 4470 and a pre-requisite of PSYC 4410, Theories of Personality be added.

### III. RATIONALE FOR THE PROPOSAL.

A. Quantitative Assessment: Indicate the types of assessment data, i.e., surveys, interviews, capstone courses, projects, licensure exams, nationally-normed tests, locally developed measurements, accreditation reports, etc., that were collected and analyzed to determine that curricular changes were warranted. Quantitative data is preferred.

Directed Research and Directed Studies:

We, in the Behavioral Sciences department, have had several students repeat a Directed Research with several faculty across multiple semesters. We would like to make these courses repeatable.

Intervention Techniques and Applications:

In following a developmental /learning perspective, it is recommended that students take relevant theoretical courses such as Psychology 4410: Theories of Personality and, to some extent Psychology 3370: Theories of Learning prior to Psychology 3340: Intervention Techniques and Applications experience. Psychological theoretical course (taught at the 3000 and early 4000 level) provide students with an appropriate foundation of knowledge to assist them in their understanding of effective treatment evaluation and selection. It is therefore recommended that students take this particular course (Psych. 3340) later in their coursework so they may be able to reflect upon prior learning and understanding.

B. Qualitative Assessment: Based upon the assessment data above, indicate why a curricular change is justified. Indicate the expected results of the change. Be sure to include an estimate of the increased cost, or reduction in cost of implementation. FOR EXAMPLE: Will new faculty, facilities, equipment, or library materials be required?

By allowing students to repeat Directed Research and Directed Studies, students can get research exposure from a variety of professors and work in multiple labs which looks great on graduate school applications.

By its nature, Psych 3340 often leads discussion into clinical topics related to practice which are often designed for students who are nearing their graduation date. It is therefore recommended that course number Psych 3340: Intervention Techniques and Applications be elevated to a 4000 level ... above the 4410 level (in this proposal, PSYC 4470). It is also recommended that Psychology 4410 be deemed a prerequisite for Intervention Techniques and Applications. Furthermore, it should be noted that no content changes are proposed for Interventions, it was determined by the program that the current content was more appropriate at the 4000 level.

In addition to the benefit to the students highlighted above no additional cost is foreseen.
