Reading and approval of minutes of December 2013 and January 2014 meetings – It
was moved and seconded to approve the minutes from Dec. 10, 2013 and Jan. 14, 2014
with suggested amendments. Motion carried.

II. Announcements/Information/Discussion

- President Rose Updates
 - ➤ HEPC meeting scheduled for Feb. 20, 2014.
 - New goals for upcoming strategic plan.
 - Combined audit with other institutions.
 - Those planning to attend Higher Education Day at the Legislature on Friday, Feb. 21: FSU Director of Admissions, FSU Director of Communication, Legislative Advocacy Committee members, Dr. Rose and other administrators.
 - Current session of State Legislature ends on March 8.
 - Now proposing a mid-year budget cut of 3.75%.
 - Oasis system fee of \$200.00 per FTE for use of Oasis.
 - Proposed across the board increase of \$504.00 for state employees. FSU received \$127,000.00 from legislature, but cost will be \$212,000.00.
 - Faculty encouraged to contact members of legislature to protest any additional funding cuts to higher ed.
 - Outcome based funding not recommended by committee at this time.
 - FSU received \$100,000.00 in matching funds for "Bucks for Brains". A greater amount of funding received by Marshall and WVU
 - ➤ Tough winter Classes cancelled on main campus Jan. 30 due to power failure. When power resumed, it was necessary to bring one building up at a time due to length of time without power. FSU closed on Feb. 3 due to the large amount of snowfall and hazardous road conditions.

BOG Representative – Robert Mild

- Meeting scheduled for Thursday.
- ➤ Sat in on conference call with several college presidents and representatives discussing budget issues. Faculty encouraged to contact local delegates re: SB 409 issues. List of names of representatives available from B. Mild.

ACF representative – Sue Kelley

- ➤ HEPC members will with legislature in afternoon and then again on Friday.
- ➤ SB 409 plan is to make sure all credits from general studies classes will transfer from 2-year institutions to 4-year institutions. This brings up issues related to accreditation as faculty are unable to ensure that all courses are same when a class is from another institution.
- > Teach for America discussion about alternate certifications and education for profit.
- Currently a bill in legislature that would take away the right of colleges and universities to prohibit guns on campus. This bill would allow students that have a "concealed carry" permit to bring their guns to campus.
- WV legislature page has information for those wishing to call and voice opinions about this bill or any other bill.
- There is continued uncertainty about the budget. The more calls the legislators receive objecting to "free fall" cuts for higher education, the more likely they will feel the pressure.
- Outcomes-based dispersion of money to the state institutions is still being considered.

Student Government – Mitch Moore and Stephanie Yost

- Has a meeting planned with A. Raisovich to discuss interactive scheduling: When registering for classes, students would be able to look at a course description and a syllabus to help them make choices. This is currently being done at Marshall. The committee members voiced their opinions regarding the initiation of interactive scheduling:
 - Will need to provide syllabus information far in advance, which may be difficult, especially as changes may need to be made just before the class actually begins.
 - May be difficult for some faculty to prepare ahead of time while still involved in ongoing semester.
 - The idea sounds good but it would help to know how it works at Marshall. Is it being used or is it an idea that hasn't been tried yet?
 - Stated that he will call his contact at Marshall to gather additional information, which he will then present to Faculty Senate.
 - A survey will also be developed to ascertain student interest.

- Student government activities planned:
 - In 3 weeks students will be electing new student government officers for the 2014-2015 school term.
 - Students will be participating in "random acts of kindness" week.
 - Involved in assisting with the campus blood drive.
 - Will be planning a spirit week to be held sometime after spring break.
 There will be a variety of activities available.

• Report of Ad-Hoc Committee on Adjunct Hiring Practices – Anne Patterson

- The purpose of the committee is to gather data and provide information/analysis to Dr. Rose.
- Members of committee: A. Patterson, D. Long, C. Kast, M. Ransome, S. Roof, C. Edwards, and C. White met and discussed numerous issues related to the Affordable Care Act and how institutions utilizing adjuncts will be affected.
- Information was acquired from Neil Tennant regarding % of classes currently being taught by adjuncts. Part-time is defined as working 30 hours or less per week.
- Cindy Curry offered to meet with the committee to discuss/answer questions related to the new guidelines.
- ➤ A survey is to be developed to collect additional information about adjuncts.
- The committee welcomes any ideas/suggestions from faculty.
- S. Kelley stated that currently ACF doesn't view the problems with adjuncts as an issue for the group to address.
